One incredible tool we have to protect individuals, their families, and our community at large, is to help put our clients on the path to U.S. citizenship. For many, the first, critical step is applying for a green card and legal permanent residence. Currently, SFDP is the only legal services organization in the state that provides free green card services. For those clients who already have their legal permanent residence, we provide free representation so they can naturalize and become U.S. citizens and enjoy full participation in civic life in the U.S.

RURAL PROGRAMS

Bringing legal services to places where immigration lawyers do not work has always been at the heart of Santa Fe Dreamers Project's mission. This year we continued our services to Taos and Valencia Counties, with a big focus on helping people who had been victims of violence through the U-Visa process. Our rural programs are only possible because of strong partnerships with community service organizations on the ground and the dedication of our community programs staff who understand the importance of showing up and building trust to reach some of the most vulnerable folks in our state.

SPECIAL IMMIGRANT JUVENILE PROGRAM

Our Special Immigrant Juvenile Program focuses on protecting the most vulnerable among us from deportation. When children face abuse, abandonment, or neglect, it is critical that their trauma is not further compounded by deportation to a place where their lives may be at risk.



"The fact that in this political climate, there is still a legal process that can formally recognize an immigrant child's abandonment, abuse or neglect by a parent or parents and on that basis, put the child on a path to a green card and citizenship in the U.S. is undoubtedly life-changing for many. SPONSORSHIP/RELEASE PROGRAM

Santa Fe Dreamers Project helped over 180 transgender women get released from several immigration detention facilities this year. One challenging aspect of our release program is that many women do not have family or friends in the United States who can sponsor them with their housing and their legal cases and provide the support needed for their first year in the U.S. Santa Fe Dreamers Project has recruited and trained sponsors in over 30 communities all over the United States. When a woman is released from prison, she comes to an apartment in Albuquerque run by SFDP staff, and through a coordinated effort with volunteers, we support her while she rests and gets organized and is brought to her new home to live with her sponsor. Additionally, we raised \$50,000 this year to start a revolving fund for women who can't possibly pay the cost of their bonds to leave prison.



"I was detained at Cibola for about 5 months. Thank God I won asylum. Since then I have been running the apartment. My job is to receive the trans women when they are released from Cibola. We provide food, a place for them to stay when they leave detention while they get organized to take the next step. Freedom from detention is a great blessing for each and every one of the trans women, because the simple fact that you are outside, breathing fresh air and eating a good meal is something very beautiful. I try to make them feel at home and help them with everything I can so that all their needs are met."

"I was just released from detention. I was detained for two years. Being released was complete joy. I have no words to explain it. When they told me that I would be free, I didn't believe it. I have worked for many years defending the rights of my community from so many abuses that we suffer, as trans women, and as members of the LGBTQ community. We suffer a lot of violence, a lot of discrimination. In my country, the government violates our rights and that is why I decided to immigrate. I never thought that I would face so much suffering by being detained for so long.

I dream big and hope to God that I will fulfill my dreams. I will keep fighting for protection for my community until the last day I am on this earth, despite any obstacles that come my way. With all of your help, I will achieve it."

NON-DETAINED DEPORTATION CASES IN EL PASO

As our expertise in removal defense grows, our team has increased their capacity to help longtime residents of the US who face removal in the El Paso Immigration Court. These cases are critical because they help members of our community remain in Santa Fe thriving and united with their children.





EL PASO IMMIGRATION COLLABORATIVE

EPIC is a massive collaborative legal project designed to bring legal representation to thousands of detained asylum seekers in the EI Paso ICE jurisdiction and bring systemic change to bear on the dehumanizing detention and court practices that are the norm in the region. In 2019, local organizations and nationwide partners came together to form EI Paso Immigration Collaborative (EPIC) in response to the injustices at the southern border. The collective of organizations consist of 5 local grassroots legal projects: Las Americas Immigrant Advocacy Center; Diocesan Migrant & Refugee Services; Santa Fe Dreamers Project; New Mexico Immigrant Law Center; and Catholic Charities of Southern New Mexico. Joining the group nationally were Innovation Law Lab, the Immigrant Justice Campaign, and Curran, Berger, and Kludt, a private immigration law firm. The idea was to come together and address the staggering issues of representing detained individuals in El Paso's ICE detention system with a creative, collaborative approach that leverages the work, wisdom, and experience of local organizations with the strategies being deployed at a national level.

The El Paso ICE jurisdiction, comprised of New Mexico and West Texas, covers one of the largest geographic areas for ICE enforcement in the United States, has an estimated 3,700 detention beds, and is notorious for being one of the most deadly places for asylum seekers to be detained. There are staggering violations of due process and one of the lowest asylum approval rates in the nation at just 3%. EPIC was founded in this landscape and with the belief that **through coordinated, data-driven services that draw on help from remote volunteers and pro bono attorneys, EPIC can change the ecosystem of courts and detention centers to make El Paso a place where people can be released from detention and where meritorious asylum claims can win.** As ICE is systematic in its detention and deportation of asylum seekers, EPIC is equally systematic in their defense. Another way of thinking about EPIC is using technology, lawyers, and love to dismantle the immigration detention industrial complex on the border.







"I left Cuba with the love of my life. We left because of a lack of freedom, an inability of being able to express yourself as you are, because of the discrimination. We left looking for a place that values justice and freedom, and that respects individuality. My first experience in the US was 3 months in immigrant detention. I escaped discrimination at home and ended up experiencing even more in detention.

The way they treat you is designed to make you feel trapped, to lose hope. I am someone who is very aware of the circumstances in which I find myself and I understood the nature of that place. They did not steal my hope. Freedom is in your mind. Regardless of how long we are subject to abuse, we have to know that we are free in our minds."

LGBTQ DETENTION DEFENSE

"I represent folks at all stages of their removal proceedings and most of my clients are detained. The average denial rate for asylum seekers in El Paso is at least 95%, so it's really difficult to win asylum here. I tend to focus mostly on queer cases. It is such a hostile jurisdiction and a lot of them don't have representation. I figured if they could have some legal assistance, they could maybe be successful even in El Paso.

My favorite part of this work is working with my clients. I really love my clients and I love being able to connect with them in a way that lets them know that I understand maybe more than most people where they are coming from. I'm able to help them navigate a system that is really confusing and can be really overwhelming.

I worked with a lesbian couple from Cuba who were detained and helped them get bond. It was great to see them released. I had never seen them together. When I would go visit them, I had to see them one by one so it was really nice to finally see them together. It just does not make sense for us to criminalize people for trying to save their lives, but until that happens, there is a lot of need down here in El Paso because we have a lot of asylum seekers."

"Last December, SFDP notified me that a number of transgender asylum seekers that had just crossed the border would be transferred to South Texas Detention Center, near where I work in San Antonio, Texas. SFDP helped me hit the ground running on helping these trans women because of their experience serving a detained trans unit in New Mexico. They shared information and insight with me. We started the work of assisting these women through release support and representation. The impact has been huge. Twenty women have won their asylum from this group and many more have been released with our assistance. These women now get to live their lives in the U.S. away from the transphobic violence in their country that they were fleeing from. SFDP's assistance and guidance was essential in getting us to this place."

FAMILY SEPARATION

The Trump Administration policy of Zero Tolerance and Family Separation during the summer of 2018 has had lasting effects on the impacted families. With support from the American Immigration Council and Hispanics in Philanthropy, our staff attorney in El Paso worked on a national team to reunite detained parents with their children. The final family that the project served was reunited in May of 2019 after nearly 10 months of separation.

PRIVATE PRISON DIVESTMENT CAMPAIGN

There are three immigration prisons in the State of New Mexico that are run by private corporations that make enormous profits off of them. This year, Santa Fe Dreamers Project initiated a campaign to make New Mexico's public aware of the atrocities of corporate detention and the divestment strategies that we can use to undermine it's profit. Anchored by Creative Director Sylvia Johnson's powerful film, *Refuge(e)*, our divestment campaign has created conversation around power and change in communities across the US and encourages community organizing for better policy in our home state.

COUNSELING PROGRAM

This year, with funding from an inaugural grant from Anchorum/St. Vincent, Santa Fe Dreamers Project was able to hire a bilingual counselor and licensed art therapist to create an in-house counseling program for our clients. Through our legal work we encounter families with fear and trauma and issues that deserve the most compassionate and professional services. Not only does this program offer those services at an agency our clients already trust, but we are also able to help make critical referrals to mental health agencies in our community and create awareness in Santa Fe around the mental health needs of immigrant and refugee families.

SAFE PLACE

SAFE Place is Santa Fe Dreamers Project's newest community legal clinic. It is developing as a response to the high number of families in Santa Fe who have recently crossed the border seeking refuge and now face the daunting task of presenting a case for political asylum in the notorious El Paso Immigration Court. Not only does SAFE Place aim to provide comprehensive legal support and accompaniment to those families, it also helps identify their non-legal needs and refer them to wraparound services in our community.

DREAMS ON WHEELS

The summer of 2019 saw our mobile law office Dreams on Wheels get the makeover she finally deserves. With the help of some friends from our community, the RV was gutted, some structural repairs were made, and the inside was completely refurbished to be a state of the art immigration law office. We are rolling into 2020 with this brand new tool to reach more remote communities and bring services to places where there are no immigration attorneys.





La Luchadora is the collaborative project Hazel developed with the Santa Fe Dreamers Project and Paleteria Oasis. She uses a paleta cart to hand out free popsicles while also discreetly handing out Know Your Rights information for immigrants on the napkins provided. La Luchadora creates a space where dialogue and information can be exchanged by subverting the role of the paletera.
